### Membership

Membership is growing, and our goal is to have **all** property owners as members. Membership includes paying dues, and it also includes being involved in our community. Involvement may mean voicing your opinion about issues relating to our neighborhood, serving as a POA officer, participating in the neighborhood volunteer clean up, and attending the annual meeting and the Trojan Horse picnic.

The benefits of being a POA member are that members can vote on decisions that impact our neighborhood. Members can serve as officers and help maintain the stability and desirability of our neighborhood. It is only when we have 2/3 of property owners as permanent members that we can require ALL property owners to contribute to road maintenance.

## **DUES**

Our current General Fund balance as of 12/31/14 was \$5,274.54.

You do not need to be a registered POA member to contribute, and contributing does not make you a member. Please read the dues schedule and return your payment for 2015 by May 1, 2015.

### **Snow Removal Fund**

Our snow removal fund had a balance of \$2,954.91 as of 12/31/14, and we will continue to dedicate these funds solely to snow removal. Donations are always welcome.

#### **Issues:**

Currently the Bylaws state:

**Article IV Section 7**. Voting by Proxy. Votes may be cast either in person or by one or more agents authorized by a dated, written proxy executed by the member or his/her attorney-in fact and *properly notarized* (italics added). A proxy terminates one year after its date, unless it specifies a shorter term. Any form of proxy which is sufficient in law may be used...

Doug Ferrell has proposed that the requirement for a notary to validate the proxy be removed. It was seconded and voted on at the Special Meeting of August 16, 2014. Sixteen votes have been cast in favor. As a 2/3 majority of the membership is required to amend the Bylaws and we have 43 members, we need a total of 29 votes in favor to remove the requirement. If you are a member and will not be able to attend the Annual Meeting, you may vote by notarized proxy.
